1 Background

According to the 1993 edition of OIML B 6 *Directives for OIML technical work*, the periodic review of technical publications was the responsibility of the Technical Committee (TC) or Subcommittee (SC) which had developed them. This regular period for publication review was not being respected under these arrangements, and this problem was discussed by the Project Group revising B 6.

2 Reviews under B 6-1:2011

The 2011 edition of B 6-1 *Directives for OIML technical work* transferred the responsibility for initiating the review of OIML technical publications to the BIML. Under this new procedure, the appropriate TC/SC was consulted first on whether a publication should be re-confirmed, revised or withdrawn. The results of this consultation were then sent to the CIML, which then voted on the same three options for the future of the publication. Depending on the result of this CIML consultation, an appropriate proposal was then put to the CIML for approval.

Three pilot reviews were conducted under this procedure, and the results are shown in Annex A. These reviews did not produce very conclusive results at the TC/SC stage.

3 Reviews under B 6-1:2017

In the 2017 edition of B 6-1, the CIML part of the procedure was amended. Under the new arrangements, the CIML simply voted on whether to accept the result of the three-option review undertaken by the appropriate TC/SC. It was hoped that this would produce clearer results, and another seven reviews, the results of which are shown in Annex B, were initiated by the BIML in 2018. Again, the results were inconclusive, mainly due to the poor levels of response at the TC/SC stage.

4 Current proposal for amendment

The proposal for amending the review procedure in B 6-1 which is put forward under this agenda item was developed following discussions at the meeting of Task Group 2023 in March 2019. It is intended to provide a way in which periodic reviews of OIML publications can be conducted successfully and efficiently to ensure that they remain as relevant and up to date as possible.
